

Web design Policies

ALJ Business & Notary Services, LLC will create a custom design website for your business or personal use. A "Web Design Form" must be completed prior to the commencement of work, in addition to a signed Service Agreement.

The Work

- We offer a FREE 30-minute virtual consultation on projects up to the point that the client signs a contract and consultations will be conducted via Zoom Meetings. All other meetings and phone calls will be charged at the hourly rate of \$35 and rounded up to the nearest minute.
- All word documents, images, files should be sent via email to info@aljbns.org.

Turnaround Time (TAT)

- Website designs are completed within 45 calendar days. Expedited design services are available for an additional fee and your website will be completed within 15 business days.
- Expedited fees must be paid prior to the commencement of site design along with appropriate package fees.

Payment for Services

- Pricing is set and rates are non-negotiable. <u>Modified payment arrangements can be made available upon</u> request.
- Upon completion of the design and once full payment has been made, the website will be transferred to the client and client will have full ownership of the website. ALJ Business & Notary Services, LLC will no longer be able to access the website unless recurring monthly maintenance is required.
- ALJ Business & Notary Services, LLC will not transfer ownership of the design to client until all fees have been paid in full.

Non-Payment of Services

- If the final payment is not received by the established due date, an additional 2.5% late fee will be assessed every 5 calendar days thereafter, up to 30 calendar days.
- Final payment and all late fees must be paid prior to ownership transfer to client.
- Any additional costs incurred for chasing and/or recovering the outstanding fees will be added to the client's account and is subject to interest.

Payment Methods

- Acceptable payment methods are money order, business check, cashier's check, credit card and Cash App: \$aljbns.
- Payments made via money order, business check or cashier's check must be received within 5 business days of invoice due date. A fee of \$35 will be charged for all returned checks in addition to a 1.5% late fee. Domain Name Purchases

- Payment of Domain Name extensions is the responsibility of the client and is not included in the web design fees.
- Domain name extensions are available for purchase through Google, GoDaddy, Squarespace, Domain.com etc. We are happy to walk you through the process if necessary.

Email Account Creation

- For business purposes, we recommend establishing an email account that is connected to your domain extension name.
- If client so chooses to establish this email account, he or she will be responsible for the applicable fees.

Maintenance

You may choose to have ALJ Business & Notary Services, LLC operate under the title of webmaster for your website. Under this title, we will perform:

• Website updates, website maintenance, blog updating, corresponding with business owner on upcoming events to include on the website, adding content, and products. Maintenance should not exceed 5 hours per month.

Any request that exceeds the established maintenance hours will be billed at \$25 per hour. We will contact you once the established maintenance hours have been exhausted. All requested maintenance must be submitted via www.aljbns.org/contact or info@aljbns.org

Web Hosting

- You will be responsible for acquiring a hosting company for your website.
- Web hosting fees are the sole responsibility of the client and will be paid directly to prospective hosting company.
